- 1.1.1 Shopfront Design Guide Supplementary Policy Document Update
- 1.2 Describe the proposal under assessment and what change it would result in if implemented.
- 1.2.1 The Council is reviewing, updating and consolidating two existing Supplementary Planning Documents (SPDs) into one new SPD. Its purpose is to provide guidance to planners and developers on the design of retail premises, shopfronts and signage, as well as the integration of security measures. It will aim to encourage entrepreneurship and economic activity by recognising the important part design

can play in achieving this. In particular, it will look at the strengths of existing buildings and streetscapes, and how these can be enhanced by better design. The SPD will support and supplement Policies EN3 and DS3 of the adopted Core Strategy (and Policies EN4 and DS3 of the emerging Local Plan).

- 1.2.2 As the previous documents were produced and adopted nearly two decades ago, national level legislation has changed in the meantime. With the introduction of the Equalities Act 2010 and an update to the Approved Document M of Building Regulations 2025, the new SPD document needs to be updated to meet these new requirements. By applying current best practice for accessibility, the design policy will be able to meet disabled, young and old people's needs to access shops.
- 1.2.3 As the above legislation has been adopted at a national and local level, they will have already undergone an Equalities Impact Assessment to measure their effects on protected characteristics. Due to this assessment being on a guidance document created to support the adopted local plan, the associated impact lies within the adoption of new policy within the local plan. Nevertheless, if accessibility is incorporated correctly within the guidance, it should have a positive impact by informing the designers and planners to be able to incorporate accessibility into their work. As there will be a positive impact a full EqIA has been completed making sure that the equality of opportunity for different groups has been advanced.

#### 2.1 Introduction

- 2.2.1 Yes. One aspect of the consolidated SPD is to support planners and developers to produce shopfront designs that give the entire community the opportunity to access them. Incorporating accessibility into the design process allows for individuals with protected characteristics to be at the forefront of design. Therefore, fostering good relations between both people who have a protected characteristic and people who do not as they will be able to share the same space.
- 2.3 Will this proposal have a positive impact and help to <u>eliminate discrimination</u> and harassment against, or the <u>victimisation</u> of people who share a protected characteristic? If yes, please explain further.
- 2.3.1 This proposal will have a positive impact on people who are of a young/old age and/or are disabled. It will impact these protected characteristics as they face the greatest physical barriers of entry to premises. Planners, developers and shop owners will utilise the SPD, therefore eliminating these barriers within the design process. When a new shopfront is completed, everyone within the community will be able to access the same space.
- 2.3.2 If people with these shared characteristics are now able to access the same space as people who do not have a shared characteristic, then they are more likely to be involved and not discriminated against. It also allows for these people to have more independence and to participate in societal norms.

3.1.2 A range of key external stakeholders will be consulted to offer their input into the production of the SPD before formal public consultation. Strategic Environmental Assessment and Habitat Regulations Assessment Screening Statements have been received from Historic England, Natural England and the Environment Agency. No other impacts on protected characteristics have been identified.

- 4.1 What evidence do you hold to back up this assessment?
- 4.1.1 Despite the national profile of 'planning' only an estimated 3% of the public engage in individual planning application consultations and only 1% on local plans. (MHCLG UIN 24262, 29th June 2021)
- 4.1.2 Planning it not considered accessible to all. The systems are complex, and the language and systems seem to be from a previous age. People with money, education, access, and time can navigate the system making it inequitable. (Paraphrased from The Future of the Planning System in England, 2021)
- 4.1.3 Planning has also seen a reduction in public sector resources to deliver planning functions and wider socio-economic changes informing the continued uptake of digital technology.

- 4.2.1 Specific consultation with the Mobility Planning Group during the formal public consultation phase will allow for their comments to be incorporated into the SPD. The Mobility Planning Group are a user-led organisation that brings together services users and providers, so they have specific knowledge addressing mobility, accessibility and travel planning.
- 4.2.2 It is expected that the formal consultation of the SPD may yield further gaps in information and evidence. This will be brought into the finalised post-consultation update of the SPD and also any revisions required on the EQIA.
